PETITION

Relator comes now before this Court and respectfully requests this Court to issue a Writ of Mandamus to order the Respondents to provide lawful access to public records which Respondents control and have improperly refused to Relator in violation of and contrary to Revised Code §149.43. Relator verifies the facts and averment of facts by Relator's affidavit attached hereto.

PARTIES

- 1. Relator is a resident of the State of Ohio, City of Nelsonville, County of Athens.
- Respondents were, or are at all times relevant herein, public officials or employees charged with management of the public records sought for purposes of Ohio Revised Code

§149.43 and this action. Respondents were at all times relevant herein responsible for protecting public records from loss, destruction, or tampering.

All records sought by the Relator are public records for purposes of Ohio Revised
 Code §149.011(G) and this action.

JURISDICTION AND VENUE

 Because the Respondents and the records sought are located or were generated in the County of Athens, State of Ohio, this court has jurisdiction and venue by and thru Ohio Revised Code §149.43(C1).

FACTUAL ALLEGATIONS COUNT ONE

- Respondent City of Nelsonville is a municipal corporation and political subdivision of the State of Ohio whose offices the law specifically enjoins as having a duty subject to Ohio Revised Code §149.43 and its records are subject to Ohio Revised Code §149.43.
- Respondent Thomas Cangemi is the City Manager for the City of Nelsonville and a person whose office the law specifically enjoins as having a duty subject to Ohio Revised Code §149.43.
- Respondent Taylor Sappington was at all times relevant herein the Auditor of Nelsonville Ohio, and a person whose office the law specifically enjoins as having a duty subject to Ohio Revised Code §149.43.
- 8. Respondents Nancy Sonic, Cory Taylor, Gregg Clement, Justin Booth, are currently council members of Nelsonville, Ohio and persons whose office the law specifically enjoins as having a duty subject to Ohio Revised Code §149.43.
- Respondent Anthony Dunfee was an appointed Council member currently being challenged by Quo Warranto in the 4th District Court of appeals of Ohio (24CA0011) that

participated and voted during relevant Council Meetings of the City of Nelsonville and a person whose offices the law specifically enjoins as having a duty subject to Ohio Revised Code.

- 10. Ohio Revised Code Section §149.351 Prohibits destruction or damage of records and mandates that all records are the property of the public office concerned and shall not be removed, destroyed, mutilated, transferred, or otherwise damaged or disposed of, in whole or in part, except as provided by law or under the rules adopted by the municipal records commissions provided for Ohio Revised Code Section §149.39.
 - 11. Tampering with records is unlawful under Ohio Revised Code Section §2913.42.
- Relator seeks records which are not under a valid exemption of Ohio Revised Code
 Section §149.43. Relator has a right of inspection and or copying of those records he seeks.
- During the March 11, and March 25, 2024, regular meetings, Relator became aware of council members, during council meetings, texting, whispering, and other actions which prevented the public from being a part of an open meeting as required by Ohio Revised Code §121.22.
- 14. On March 26, 2024, Relator, made by email a public record request of records related to the requirement to hold public meetings. (Exhibit 1).
- 15. The March 26, 2024 record request gave a preservation notice to preserve all records for any future court dispute. (Exhibit 1)
 - 16. On March 27, 2024, Relator expanded his record request. (Exhibit 2)
- Attorney Matthew Voltolini which included case law and sections from training manuals of training that all council members are required to obtain by Ohio Revised Code §109.43(B). (Exhibit 3 Two pages)

- 18. Mathew Voltolini responded to Relator by phone stating he was sending an email to all involved parties asking all parties to provide the requested records.
- 19. Respondent Thomas Cangemi, responded by email on March 30, 2024 acknowledging the request stating he had other requests that were submitted prior to the Relator's request which had to be completed before processing the Relator's request. (Exhibit 4)
- 20. Relator responded to the City Manager's email on March 30, 2024, stating that the law required a response in a reasonable amount of time and that the City Manager was welcome to call the Relator at any hour if he needed clarification. The Relator also restated that records in the possession of the City Auditor and Council Members had been requested. Those records were not held by the City Manager. (Exhibit 5)
- 21. On April 1, 2024 Relator emailed the City Auditor Taylor Sappington detailing the public records of relator's March 26, 2024 request that were held in office of the City Auditor and asking him to forward the record electronically. (Exhibit 6)
- As of the date of the filing of this petition no Respondent has yet to provide any documents or otherwise lawfully explained an exemption to providing the requested documents to the Relator.

CLAIMS FOR RELIEF

Claim One: Writ Of Mandamus Directed To Respondent

- 23. The allegations set forth in paragraphs 1 thru 22 are incorporated herein by reference.
- 24. Pursuant to Ohio Revised Code §149.43(C)(1), Relator is entitled to a conclusive presumption of injury arising from the loss of use of the public records sought.

25. Pursuant to Ohio Rev. Code §149.43(C), Relator is entitled to a writ of mandamus from this court commanding Respondent to comply with Chapter §149.43 of the Ohio Revised Code and to otherwise restore Relator's right to inspect and or to copy the public records sought.

Claim Two: Monetary Damages

- 26. The allegations set forth in paragraphs 1 thru 25 are incorporated herein by reference.
- 27. Relator is entitled to money damages in the amount of one hundred dollars (\$100) for each day that Respondent improperly caused Relator to lose access to the public records. Ohio Rev. Code §149.43(C)(1), beginning on the day of filing of this action, up to a total of \$1000.
- 28. Relator is entitled to costs, expenses and reasonable attorney's fees of this action, and other such relief as the Court deems just and proper.

PRAYER FOR RELIEF

WHEREFORE, Relator respectfully prays that this Court:

- 1. Enter judgment that Respondents' continuing denial of the access to requested public records is unlawful and against the public interest and for which the issuance of a Writ of Mandamus by this Court to compel the production of such records to the Relator is lawful and warranted.
- 2. Issue a Writ of Mandamus to be served upon the Respondents personally, by copy, by the sheriff or by a person specially authorized by the court or judge issuing the writ, commanding Respondents to permit Relator's right to access the requested public records in the attached Exhibits and named in the petition for immediate inspection and/or copying.
- 3. Enter judgment in Relator's favor for statutory damages fixed at one hundred dollars for each business day during which the public office or person responsible for the

requested public records failed to comply with an obligation in accordance with division (B) of this section, beginning with the day on which the Relator filed this mandamus action to recover statutory damages, up to a maximum of one thousand dollars. Enter judgment in Relator's favor for expenses, costs, and reasonable attorney's fees of this action, to be ascertained by the Court and other such relief as the Court deems just and proper.

 Enter a Judgement of conclusive presumption of injury arising from the loss of use of the public records sought by the Relator.

b. Text messages

Like email messages, a text message may be a public record if the content or information in the message documents the activities of the public office. 40 The Ohio Court of Claims held that text messages on public employees' personal phones were public records because the content of the messages documented the activities of the office.

In Sinclair Media III, Inc, V Cincinnati [Cite as Sinclair Media III, Inc. v. Cincinnati, 2019-Ohio-2623.]

The Ohio Court of claims ruled:

Sinclair's request for "all text messages from Cincinnati city council members, Mayor John Cranley and Harry Black in which Black's employment status is discussed" is a proper request.

ORC 121.22 (A) This section shall be liberally construed to require public officials to take official action and to conduct all deliberations upon official business only in open meetings unless the subject matter is specifically excepted by law.

I observed 4 members of the council engaging in Text messages during a council meeting. Some of the text messaging was extensive during the meeting. I have copied the March 25th YouTube of the council meeting.

I also observed Greg Clement go to Tony Dunfee and Cory Taylor and whisper. More discussion which was not open to the public.

In an effort to avoid a lawsuit, I am asking you to facilitate the production of the records which I have requested. If by any chance the City wants to deny my request.


